DRAFT PRESIDENTIAL DECLARATION

1. Security Council resolution 687 established in operative paragraphs 8, 9 and 10, Iraq's obligations to destroy, under international supervision, all its chemical and biological weapons, its missiles with a range beyond 90 miles and refrain from the use, development, construction and acquisition of any of these weapons.

2. UNSC Resolution 1284 created as a subsidiary organ the United Nations Monitoring Verification and Inspections Commission (UNMOVIC), to verify Iraq's compliance with the provision of resolution 687.

3. Resolution 1441 established an enhanced system of inspections with the object of arriving at a definite and complete process of disarmament of Iraq and requested a report 60 days after the commencement of the inspections.

4. The Executive Chairman of UNMOVIC has reported that the inspections were reinstated in Iraq as of 27 of November, 2002. Furthermore, he has presented two written reports on January 27 and on February 28, 2003 and has participated in three public sessions, held on January 27, Feb 14 and March 7, 2003, in the course of which he reported to the Council that Iraq has allowed expeditious access to all requested sites without exceptions. He also reported that Iraq has not offered any new evidence or information that could help to solve the pending disarmament questions.

5. The Executive Chairman's report to the SC contained elements which indicate that although there has been progress in the disarmament of Iraq it has not been sufficient or adequate. Some members of the Council have pointed out that Inspections cannot continue indefinite. Thus, the Council will have to establish the usefulness of inspections as a means to obtain, in a reasonable period of time, the complete and verifiable disarmament of Iraq or should other measures be apply to obtain this results.

6. To this end:

On the basis of the recent report of clusters declassified by UNMOVIC, the council has decided without prejudice to the need for full implementation of res. 1441. The council decides that: Iraq should, no later than ^{1.5}30 days after the adoption of the present resolution, complete the following immediate disarmament tasks:

- a) The authorization to interview at least 30 scientists outside Iraq.
- b) Disclosure all mustard gas filled shells and mustard gas filled aerial bombs unaccounted for since 1998 or full documentation providing its destruction;
- c) Provide disclose of 10,000 liters of anthrax unaccounted for or full documentation providing its destruction;
- d) Destruction of al Al Samoud missiles and components, including warheads, launchers, SA-2 missile engines and equipment and components designed for the production and testing of Al Samoud 2 missiles
- e) Provide full documentation on the purpose of the Remotely Piloted Vehicles (RPV's).

In any case, and as a principal part of this package, the leadership of Iraq must write a letter addressed to the Secretary General and the President of the Security Council, indicating that Iraq will without delay yield to UNMOVIC and IAEA for destruction all remaining prohibited weapons, proscribed item and related documentation in data.

Iraq will fully cooperate with UNMOVIC and IAEA in immediately addressing and resolving all outstanding questions.

The letter should also indicate the appropriate means to be used so that the following becomes the duty of all Iraqi government personnel and citizens immediately:

- to cease any proscribed activity;
- to hand over any proscribed items or documentation and data about such items in their possession to UNMOVIC and IAEA.

7. Furthermore, and upon completion of the of three weeks the Council shall determine, that Iraq will have failed to take the final opportunity afforded by resolution 1441 unless it

has demonstrated that is cooperating fully, unconditionally to comply with the benchmarks set out in paragraph Of the present Declaration or decide the continuation of the process of inspections on the basis of a Program of Work to be submitted by the Executive Chairman of UNMOVIC and IAEA to secure the objective of disarmament of its WMD in accordance with UNSC resolution 1441.

8. The Council offers a full amnesty for all Iraqi officials who extend their full and unequivocal cooperation to UNMOVIC and IAEA and other UN agencies and to the UNSC to secure full and faithful compliance by Iraq with the above mentioned obligations and assures them of protection and security for their person and their families.

9. The Council shall remain seized of the matter.
